NORTH FLORIDA FLY FISHERS PARTICIPATION AGREEMENT

PLEASE READ CAREFULLY

THIS DOCUMENT CONSTITUTES A WAIVER AND RELEASE OF LIABILITY

In connection with my membership in the North Florida Fly Fishers (“Club”) and participation in Club meetings, events and other activities (“activities”), I hereby acknowledge that I fully understand and accept that there are certain hazards and elements of danger inherent in many if not all human endeavors and especially sporting activities in and around nature. Fly fishing is no exception. The dangers inherent in the activities of the Club are beyond the control of the Club members, officers, directors, employees, trip coordinators, guides, agents, and the like. I voluntarily want to participate in the activities of the Club and realize that my participation in such activities may result in personal illness or injury, due to a variety of causes such as accidents, the forces of nature, or other causes either foreseen or unforeseeable. Such illness and injury may include disease, strains, sprains, fractures, disability. I also realize that my participation in the various activities of the Club may also result in the loss of or damage to personal property.

In addition, I understand that the Club sponsors activities where the group is collectively responsible for the conduct of the activities. Further, I understand that no one but myself is responsible for judging my qualifications or for my safety when I choose to participate in any activity. I will undertake to follow safety precautions and act responsibly at all times. I acknowledge and accept that I will be personally responsible for any property damage or personal injury caused by my acts or omissions during my participation in Club activities. I further state that I am legally competent to sign this waiver and release of liability on my behalf and on behalf and that I understand that the terms herein are contractual. I have read this waiver before signing it and I have signed it voluntarily. This waiver has no expiration date.

Now and therefore, intending to be legally bound, I hereby, for myself, release from liability the Club members, officers, directors, employees, trip coordinators, guides, agents, and the like, and also waive any right to sue and/or recover damages from the Club, its members, officers, directors, employees, trip coordinators, guides, agents, and the like, for any illness or injury, loss of life, and any damage or loss of personal property which may arise out of participation in the Club’s activities.
